DORCHESTER MINERALS, L.P. ANNOUNCES ITS SECOND QUARTER DISTRIBUTION

DALLAS, TEXAS -- Dorchester Minerals, L.P. announced today the Partnership's second quarter 2010 cash distribution. The distribution of \$0.412207 per common unit represents activity for the three-month period ended June 30, 2010 and is payable on August 12, 2010 to common unitholders of record as of August 2, 2010.

Cash receipts attributable to the Partnership's Net Profits Interests in pay status during the second quarter totaled approximately \$2.7 million. These receipts reflect oil and gas sales from the properties underlying the Net Profits Interests generally during February through April 2010. Approximately \$0.7 million of gross capital expenditures, primarily attributable to drilling and completion activity, was re-invested by the owner of the working interests in the properties underlying all the Net Profits Interests during March through May 2010. Cash receipts attributable to the Partnership's Royalty Properties during the second quarter totaled approximately \$1.1 million. These receipts generally reflect oil sales during March through May 2010 and gas sales during February through April 2010.

The Partnership received approximately \$1.0 million of other cash receipts during the second quarter and identified 79 new wells on the Partnership's Net Profits Interests and Royalty Properties located in 35 counties and parishes in eight states.

Dorchester Minerals, L.P. is a Dallas-based owner of producing and non-producing oil and natural gas mineral, royalty, overriding royalty, net profits, and leasehold interests located in 25 states. Its common units trade on the Nasdaq Global Select Market under the symbol DMLP.
