Dorchester Minerals, L.P. Announces Third Quarter Results

DALLAS, TX -- (Marketwired) -- 11/07/13 -- Dorchester Minerals, L.P. (the "Partnership") (NASDAQ: DMLP) announced today the Partnership's net income for the quarter ended September 30, 2013 of \$10,749,000, or \$0.34 per common unit.

The Partnership previously declared its third quarter distribution in the amount of \$0.455287 per common unit paid on October 31, 2013 to common unit holders of record as of October 21, 2013. The Partnership's cash distributions are not comparable to its net earnings due to timing and other differences including depletion.

Dorchester Minerals, L.P. is a Dallas based owner of producing and non-producing crude oil and natural gas mineral, royalty, overriding royalty, net profits, and leasehold interests and its common units trade on the NASDAQ Global Select Market under the symbol DMLP.
